

## SCHEME FOR THE AWARD OF CHANDIGARH (UT) GOVT. MERIT SCHOLARSHIP ON THE RESULT OF BA/BSC EXAM

THE ELIGIBILITY CONDITIONS OF THIS SCHOLARSHIP ARE AS UNDER :

1. i) For Salaried Class basic pay plus income if any other sources is taken into account allowances of pay included.  
ii) In case of income from source liable to income tax income competed (after deduction for debatable items) for the purpose of assessment of income tax.  
iii) In case of income not liable to income tax such an income from Agriculture etc. then net income that is arrived at after deduction expenses incurred for earning that income.
2. That he should secure atleast second decision in the specified examination subject to the further condition class, the candidate must secure atleast 2nd class in the specified subject also.
3. That these scholarships will be awarded /continued for the general course of study only.
4. The scholarship shall be paid for the pull academic year (i.e. 10 months from the commencement of the academic year i.e. period from which fees slip ordinarily payable.
5. The Heads of institutions shall be permitted to grant liberal fee concessions including all kinds of fees except admission fee and pays to the students concerned enjoying scholarship this scheme over and above the normal quota of full and half fee concessions allowed to them but no expenditure will be reimbursed to non Govt. institutions.

4. Any change in the address or course/class or institution of study must be intimate to the Registrar of this University/Director of Public Instruction , Chandigarh Administration, Chandigarh.
5. The scholarship is liable to be cancelled if any information supplied in the application form/declaration /certificate is alter on found to be incorrect or the student becomes or found ineligible for any other ground.
6. MEANS TEST.

The payment of scholarship under this scheme will be subject to the following provisions :-

- i) Scholarships under the scheme for Post graduate study (viz MA/MSC/Ph.D etc.) will be paid without any consideration of the income of the parents of the candidate.
- ii) In the case of Graduate course, only these students whose parents have joint family income of Rs.500/- or below per month will be eligible for the scholarship. The term Income for the purpose of the means tests under this clause is defined as under :-
  - a) Total income of the family should include income only of father and mother and the scholar and of no other member though they may be earning.
  - b) In the case of salaried class, basic pay plus income, if any, from other source and will not include dearness pay allowance like dearness allowance.
  - c) In case of income from sources liable to income tax income computed (after deduction for rebatable items) for purpose of assessment of income tax.
  - d) In case of income no liable to income tax. Such as income from Agriculture etc. then net income that is arrived at after deduction of expenses incurred for earning that income.

#### EXPLANATION -I

In case of persons drawing income from salary income under clause (a) and clause (b) above, Dearness pay allowance, City compensatory allowance, House Rent allowance or value of rent free accommodation, conveyance allowance and overtime allowance etc., shall not be included in determining the income. Deputation allowance, NCC, Honoraria or Honoraria for undertaking other work, special pay and bonus etc. shall however be treated as income.

#### EXPLANATION-II

For the purpose of determining the salary income in clause (a) and (b) from the basic salary act as deductions for computing the taxable income will be deducted all items which are allowable under the income tax.

7. It may be added for the information that Chandigarh UT Govt. Merit Scholarships are admission only to the students who passed the specified examination from Chandigarh with atleast second division (either privately or through the institution situated at Chandigarh) and pursue their studies in the specified course in the affiliated institutions.

#### SCHEME OF POST MATRIC SCHOLARSHIP (SC/ST)

##### OBJECT :

The objective of the scheme is to provide financial assistance to the Scheduled caste students studying at Post Matriculation or post secondary stage to enable them to complete their education.

##### SCOPE

The Scholarship are available for studies in India only and are awarded by the government of the State/ Union Territory to which the applicant actually belongs i.e. permanently settled.

##### MEANS TEST

Scholarship will be paid to the students whose parents/guardians income from all sources not exceed Rs. 1,00,000/- per annum.

Note- 1 :- House rent allowance received by the parents of a student shall be exempted from the computation of income if the same has been permitted to be exempted for purpose of Income tax.

Note -2:- Income certificate is required to be taken once only i.e. at the time of admission to courses which are continuing for more than one year.

Note -3 The revised income ceiling s account for Consumer price index for Industrial workers upto October 2002. Income ceiling would be revised once in every two years linking it with consumer Price Index for industrial workers for the month of October of the year, preceding the year of revision and will be effective from April.

#### CENTRALLY SPONSORED SCHEME OF POST MATRIC SCHOLARSHIP TO STUDENTS BELONGING TO SCHEDULED CASTE- GROUPING OF COURSES

##### Group GROUPING OF COURSES

I Degree and Post Graduate level courses (including M.Phil,Ph.D and Post Doctoral research in Medicines (Allopathic, Indian and other recognized systems of medicines) Engineering Technology, Agriculture Veterinary and Allied Science, Management, Business Finance, Business Administration and Computer Applications/Science Commercial Pilot License including helicopter pilot and Multi Engine rating course.

II Other professional and technical graduate and post graduate (including M.Phil, Ph.d and Post Doctoral research) level courses not covered in Group I C.A/ICWA/CS/etc. courses. All Post graduate, graduate level diploma courses, all certificate level courses.

III All other courses leading to a graduate or above degree (not covered in group I & II.

IV All post matriculation level courses before taking up graduation like classes XI and XII in 10+2 system and intermediate examination etc. not covered in Group II or III,

ITI courses, other vocational courses(if minimum required qualification to pursue the course is at least matriculation).

#### CONDITION & ELIGIBILITY

1. These scholarships will be given for the study of all recognized post matriculation for post-secondary courses pursued in recognized institutions with the following exceptions :-

“Scholarships are not awarded for training course like Aircraft maintenance Engineer’s Courses and Private Pilot license Courses. Courses at Training ship Dufferin (Now Rajendra), Courses of training at the Military College, Dehradun, courses at pre-examination Training Centers of all India and State levels”

2. Only those candidates who belong to Schedules Castes so specified in relation to the State/Union Territory to which the applicant actually belongs i.e. permanently settled and who have passed the Matriculation or Higher Secondary or any examination of a recognized University or Board of Secondary Education will be eligible.

3. Candidates who after passing one stage of education are studying in the same stage of education in different subject eg 1 SC after IA or B.Com after BA or MA in other subject will not be eligible.

4. Students who after having completed their educational career in one prof. Eg LLB after BT/BEEd will not be eligible from the academic year in two professional courses are allowed.

5. Students studying in Class XI of the Higher Secondary Schools course of the XII Class of the Multipurpose Higher School will not be eligible for it being a continuous school course. However, in case where both class examination of such course is treated as equivalent to Matriculation and students who after passing 10th class join other courses, such students will be treated as post matric students and will be eligible for the award of scholarships.

6. Students pursuing post graduate courses in medicine will be eligible if they are not allowed to practice during the period of their course.

7. Students who after failing or passing the under graduate /post graduate examinations in Arts Science/Commerce join any recognized professional or Technical certificate/diploma/degree courses will be awarded scholarships if otherwise eligible No subsequent failure will be condoned except courses in Group.

8. Students who pursue their studies through correspondence courses are also eligible. The term correspondence includes distant and continues education.

9. Employment Students whose income combined with the income of their parents/guardians does not exceed the maximum prescribed income ceiling are made eligible for post matric scholarships to the extent of reimbursement of all compulsory payable non refundable fees.

10. All children of the same parents/guardians will be entitled to receive benefits of the scheme.

11. A scholarship holder under this scheme will not hold any other scholarship/stipend, the student can exercise his/her option for either of the two scholarships/stipends, whichever is more beneficial to him/her and should inform the awarding authority through the Head of the Institution about the option made. No scholarship will be paid to the students under this scheme from the date he./she accepts another scholarship/stipend. The student can however accept free lodging or a grant or adhoc monetary held from the State Govt. or any other source for the purchase of books, equipment or for meeting the expenses or board and lodging in addition to the scholarship amount paid under this scheme.

12 Scholarship holders who are receiving coaching in any of the pre-examination training centers with financial assistance from the Central Govt./State Govt will not be eligible for stipend under the coaching schemes for the duration of the coaching programme.

Scheme of Scholarship to students for Non-Hindi Speaking States for Post Matric students in Hindi

#### GUIDELINES FOR THE SCHEME OF SCHOLARSHIP TO STUDENTS FROM NON HINDI SPEAKING STATES FOR POST MATRIC STUDIES IN HINDI.

##### 1. OBJECT

The main object of the scheme is to encourage the study of Hindi in Non-Hindi speaking states and to make available to the Governments of these States, suitable personnel to man teaching and other posts where knowledge of Hindi is essential.

##### 2. SCOPE

The Scholarships under the scheme will be given from class XI to Ph.D level for recognized fulltime courses of education for study of Hindi as one of the subjects on the basis of the results of “examinations next below” conducted by a Board of Education or a University or a Voluntary Hindi Organization.

- i) 10th class/ Matriculation High School- For award of scholarship in +2 level/pre University/pre Degree.
- ii) 12th Class of 10+2 pattern/Intermediate/pre University/pre Degree- For award of scholarship in BA/B.Sc/B.Com(Pass or Honors) or an equivalent examination.
- iii) BA/B.Sc/B.Com(Pass or Honors) or an equivalent examination – For award of scholarship in MA.,M. Litt. and equivalent courses and Hindi Teachers Training Course.
- iv) MA Hindi M.Litt. (Hindi )/Pre Ph.D/qualification leading to the admission to Ph.D(Hindi) Degree- For award of scholarship in Ph.D. (Hindi)
- v) Full- time courses in Hindi for which examinations are conducted by Hindi Voluntary Organizations engaged in the propagation of Hindi or by Universities provided these examinations are recognized as equivalent to Intermediate or above. These will be given on the basis of the results of the “Examination next below”.
- vi) Training courses in Hindi Teacher’s Training College run by the Government or Hindi Voluntary organization provided these are either recognized by a State Government or are conducted by an Institution declared as an institution of national importance by an Act or Parliament. Candidates taking up B.Ed/B.T. where both content and method of teaching Hindi are studied will also be eligible. Scholarships will be awarded on the basis of the result of the examination which makes the candidate eligible for admission to the course.

vii) Course conducted by institutions declared as institutions of national importance by an Act of Parliament, provided these course are equivalent to Intermediate or above. These will be awarded on basis of admission qualification for these courses.

### 3. CONDITIONS OF ELIGIBILITY

i) Only those candidates whose mother tongue is not Hindi and who belong to any of the following Non- Hindi Speaking States/Union Territories will be eligible for the scholarship.

Andhra Pradesh, Assam, Gujarat, Jammu & Kahmir, Karnataka, Kerala, Maharashtra, Manipur, Meghalaya, Nagaland, Orissa, Punjab, Sikkim, TamilNadu, Tripura, West Bengal, Andaman and Nicobar Islands, Arunachal Pradesh, Chandigarh Dadra and Nagar Haveli, Goa Daman & Diu, Lakshadweep, Mizrom and Pondicherry

ii) Candidates who belong to Non- Hindi Speaking States specified in Rule 4(i) above but have residing for any purpose in a Hindi Speaking State will not be eligible for scholarship under this scheme. This condition of residence will not apply to candidates who are already studying in Hindi Speaking States on scholarships awarded under the scheme upto 2003-04.

iii) Candidates in employment, whether full or part-time or whether in a private organization or a government organization, will not be eligible unless they are sponsored by the State Government/ Union Territory Administration concerned and provided they execute a bon with the State Government/ Union Territory Administration if so, required by them.

Explanation : The certificate regarding sponsorship is not required to be given to the Government of India. This certificate will be taken into consideration by the State Government/ Union Territory Administration concerned while deciding the eligibility of the candidate.

iv) Candidates studying for a bachelor's degree will not be eligible for a scholarship unless they have taken Hindi as a subject which will make them eligible for admission to MA(Hindi) course of the same University. This condition will not apply in case of universities which do not conduct MA(Hindi) examinations.

v) Candidates who are studying for MA course will not be eligible for a scholarship unless they have taken Hindi as their principal subject . (This applies to cases of Universities, where candidates have to offer two subjects for the MA degree).

vi) Candidates who wish to pursue their studies through correspondence course or who are preparing for an examination privately, will not be eligible.

vii) Since this scholarship is in the form of an incentive to study Hindi, a candidate in receipt of this scholarship is not debarred from receiving any other scholarships irrespective of terms and conditions of those scholarships. A fee concession, in part or full, is not considered as a scholarships or a stipend for this purpose. Scholars studying for Ph.D course can be permitted to accept remuneration for teaching, provided it is part of study or research.

### 4. TENABILITY :

The scholarships are tenable for study in recognized institutions only. The scholarship will be awarded to those students whose mother tongue is not Hindi and are studying in Non-Hindi Speaking States. The minimum eligibility requirement for award of scholarship under the Hindi Scheme is that the student should secure atleast 60% marks in the qualifying examination.

## 6 SELECTION OF CANDIDATES :

- i) A students will be selected by the Non- Hindi Speaking State to which the student belongs against its quota..
  - ii) Only those candidates will be eligible who have passed the “next below examination” (the examination which is the minimum qualification for admission to the course now joined by the students) either in the year of award (the year in which the application for scholarship is made) or in the year immediately preceding the year of award.
  - iii) Only those candidates will be eligible who have passed the ‘next below examination’ with Hindi as one of the subject or have passed another examination in Hindi recognized by the Government of India as equivalent to the next below examination’.
  - iv) Only those candidates will be eligible who have passed the “next below examination’ in the first attempt.
- v) If after considering the candidates mentioned in Rule 7 (iv) above, some scholarship out of the quota allotted to particular State remain available, candidate who passed the examination mentioned in Rule 2 in earlier years, may also be considered.

## 7. DURATION AND RENEWAL OF AWARDS :

- i) An award once made will be tenable only for the stage of course for which it is given subject to good conduct and regularity in attendance. Within a course which is continuous for a number of years, the scholarship will be renewed from year to year provided the scholar passes in Hindi, secures promotion to the next higher class, and Hindi continues to be part of the course of study in the next higher class. The period of scholarship for Ph.D will be 2 years, but this may be extended for one more year at the most, subject to good progress in research work and the recommendation of the appropriate academic authorities.

### EXPLANATION :-

The award is tenable for only one stage of education. For example, candidates who are awarded scholarships for the P.U.C. class will have to apply afresh for BA/BSc/B.Com course through the State Government, and take their chance along with other applicants for courses. Similarly candidates awarded scholarship for BA/BSc/B.Com course will have to apply fresh for the MA(Hindi) course, and take chance. But, in case of continuous course promotion from BA-I to BA-II or from BA II to BA-III or from MA(prev.) to MA (final), the renewal would be automatic, subject to submission of an Annual Progress Report and fulfillment of other conditions of award.

- ii) Candidates who have been admitted to a three year degree course will receive the scholarship for one year, two years or three years if the Hindi examination is taken at the end of first year, second year and third year respectively, i.e. the period for which they are required to study Hindi compulsorily.
- iii) If the scholar is unable to appear for the annual examination within a continuous course owing to illness, the scholarship may be suspended till the scholar secures promotion to the next higher class subject to the submission of a medical certificate to the satisfaction of the Head of Institution and on his certifying that the scholar would have passed had he appear in the examination.
- iv) If a scholar fails to pass the examination or fails in Hindi the award will be cancelled.
- v) The award once cancelled will not be restored.
- vi) The scholarship will be renewed on the basis of an Annual Progress Report to be submitted by the Head of the Institution where the scholar is studying .

## 8. PAYMENT :

- i) Although the scholarship will be sanctioned for the academic year, the payment to the scholar will be made in regular monthly installments through the Head of the Institution.

ii) The payment of scholarship will start from the month of joining the institution and will end with the month in which the annual examination is completed. In the case of renewal of scholarship for the succeeding year, the payment will be made from the month following that for which the scholarship was paid during the previous academic year, provided the course of studies is continuous.

iii) In case of absence due to illness the scholarship will be admissible provided the period of illness does not exceed three months, a medical certificate is submitted to the satisfaction of the Head of the Institution and his certifying that the scholar is likely to make up deficiency in lectures and studies during the rest of the period of the course of studies.

#### 9. OTHER CONDITIONS FOR THE AWARD :

i) The scholars shall devote themselves to their studies to the entire satisfaction of the Head of the Institution and shall not undertake any paid work, whether part or full-time or whether under a Government or Private Organization except as provided under Rule

4 (Vii).

ii) In case, scholar migrates from one institution to another without changing the course, he should immediately inform the concerned authority of the change through the Head of the Institution, newly joined by him.

iii) In case a scholar changes over to a course not providing study of Hindi he will have to refund the amount of scholarship received by him in the year in which he changes the course.

#### 10. ANNOUNCEMENT OF THE SCHEME :

The State Government/Union Territory Administrations concerned will announce the scheme every year after the issuance of administrative approval by the Government of India continuance of scheme and invite applications by issuing a press advertisement.

#### 11. PROCEDURE FOR APPLYING :

i) The application should comprise :-

(a) One copy of the application of scholarship in the prescribed form for the year.

(b) One copy of a recent passport size photograph with signature (to be pasted on the application form in the space provided for it); and

(c) One attested copy each of the certificate, diplomas, degree, marks sheets, etc., in respect of all examinations passed since Matriculation. Original documents should not be sent unless especially called for. The Government will not be responsible if the original documents sent without being called for, are lost.

ii) Candidates must ensure that they apply through the State to which they belong as defined under Rule 7(i) of these Rules.

iii) The application forms will be supplied by the Non Hindi Speaking States to whom the applications are to be submitted. Application forms will not be supplied by the Government of India.

iv) Each Non- Hindi Speaking State Government will prescribe the authority which will supply the application forms and to whom the completed application forms are to be submitted. Application sent to any other authority are liable to be rejected.

v) Completed applications must be submitted by the date prescribed by each Non – Hindi Speaking State in the newspapers. Applications received by the State Government after the last date prescribed, are liable to be rejected

vi) Incomplete application are liable to be rejected.

vii) Incorrect entry in the application form or wrong declaration in any respect would make the scholarship liable to cancellation and/ or to penalties to be determined by the Government.

#### 12. SUBMISSION OF APPLICATION AND SELECTION OF CANDIDATES FOR AWARD OF SHOLARSHIPS :

i) Applications are required to be submitted to the Non- Hindi Speaking State Government/ Union Territory Administration to which the candidate belongs as defined in Rule 7(i) of these Rules. Voluntary Hindi Organizations are also required to send the applications to the State Government/Union Territory Administration concerned. The Non- Hindi Speaking State Government/ Union Territory Administration will make the final selection of the scholars and will issue award letter to the scholars through Head of Institutions concerned with instructions to send their acceptance letters to the Officer designated by the State Government/Union Territory Administration for further necessary action regarding payment of amount of scholarship to the scholars. The applications received by them on the basis of which selection of scholars is made will not be forwarded to the Ministry of Human Resource Development but will be kept by them for their record.

ii) Institutions conducting courses of Voluntary Hindi Organizations must submit the applications THROUGH PARENT BODY.

## SCHEME OF POST MATRIC SCHOLARSHIPS TO OTHER BACKWARD CLASSES STUDENTS FOR STUDIES IN INDIA

### I -- OBJECT

The Govt. of India has since independence initiated a number of steps for improving the level of literacy and education . In this context, the Govt. has recognized that educational and economic support for backward classes has not been adequate and that there is disparity between them and the non-backward sections of the population at every level,. It is self evident and universally accepted that education is one of the key instruments of effective development of weaker sections.

Based on the recommendations of the working Group on Development and welfare of backward classes, it is proposed to launch a new Centrally sponsored scheme of Post matric scholarship for Other backward classes (OBCs) students.

The objective of the scheme is to provide financial assistance to the other backward classes (OBC) students studying at post matriculation of post secondary stage of enable them to complete their education.

## II—SCOPE

These scholarships shall be available for studies in India only and will be awarded by the Govt. of State/ Union Territory to which the applicant actually belongs. i.e. permanently settled. 100% central assistance will be provided to State Govts/UT Admns for this purpose.

## III- CONDITIONS OF ELIGIBILITY.

- i) The scholarships will be open to Indian nationals belonging to other backwards classes as notified by the Central Govt./state Govt./UT Admn.
- ii) These scholarships will be given for the study of all recognized post-matriculation or post- secondary courses pursued in recognized institutions with the following exceptions:  
“ Scholarships shall not be awarded for training courses like Aircraft Maintenance Engineer’s Courses and Private Pilot License Courses, Courses at Training-Ship Dufferin (Now INS Rajendra), Course of training at the Military College, Dehradun, Courses at Pre-examination Training Centres of All India and State levels and Trade Courses at the Industrial Training Institutes”.
- iii) Only those candidates who belong to Other Backward Classes so specified in relation to the State/ Union Territory to which the applicant actually belongs, i.e., permanently settled and who have passed the Matriculation or Higher Secondary or any higher examination of a recognized University or Board of Secondary Education will be eligible.
- iv) Candidates who after passing one stage of education are studying in the same stage of education in different subject e.g. I SC after I A or B.Com after B.A. or M.A. in a subject after M.A. in another subject will not be eligible.
- v) Students who, after having completed their educational career in one professional line, e.g. LLB after B.T./B.Ed will not be eligible.
- vi) Students studying in Class XI of the Higher Secondary School courses or the XII class of the Multipurpose High School will not be eligible for it being a continuous school courses. However, in cases, where tenth class examination of such courses is treated as equivalent to Matriculation and students who after passing tenth class join other courses, such students will be treated as post-matric students and will be eligible for the award of scholarships.
- vii) Students pursuing Post-graduate courses in medicine will be eligible if they are not allowed to practice during the period of their course.
- viii) Students who after failing or passing the Under Graduate/Post graduate examination in Arts/ Science/Commerce join any recognized professional or Technical certificate/diploma/degree courses will be awarded scholarships if otherwise eligible . No subsequent failure will be condoned except courses in Group ‘A’ and no further change in the course will be allowed.
- ix) Students who pursue their studies through correspondence courses will be eligible towards reimbursement of non-refundable fee. This term correspondence includes distant and continuing education. Besides reimbursement of non-refundable fee, such students will also be eligible for an annual allowance of Rs. 500/- for essential/prescribed books, as applicable.
- x) Employed students whose income combine with the income their parents/guardians does not exceed Rs. 44,500/- per annum shall be eligible for post-matric scholarships to the extent of reimbursement of all compulsorily payable non-refundable fees.
- xi) Only two children of the same parents/guardian will be entitled to receive scholarships. This restriction will, however, not apply to girls. Accordingly scholarship

availed by girls of same parents/guardians will not adversely affect admissibility or availing scholarship upto two boys of same parents/guardian.

xii) A scholarship holder under this scheme will not hold any other scholarship/stipend. If awarded any other scholarship/stipend, the students can exercise his/her option for either or the two scholarships/stipends, whichever is more beneficial to him/her and should inform the awarding authority through the Head of the Institution about the option made. No scholarship will be paid to the students under this scheme from the date he/she accepts an other scholarship/stipend. The student can however, accept free lodging or a grant or adhoc monetary held from the State Government or any other source for the purchase of books, equipment or for meeting the expenses on board and lodging in addition to the scholarship amount paid under this scheme.

xiii) Students who have already received coaching in any of the pre-examination training centres with financial assistance from the Government will not be eligible.

xiv) In case of unemployed students whose parents/guardians income from all sources does not exceed Rs. 44,500/- per annum will be entitled for the scholarship under the scheme.

Note 1. So long as either of the parents ( or husband in the case of married unemployed girls student) are alive, only income of the parents/husband, as the case may be from all sources has to be taken into account and of no other members even through they may be earning. In the form of income declaration, income is to be declared on this basis . Only in the case where both the parents(or husband in the case of married but unemployed girl student) have died, the income of the guardian who is supporting the student in his/her studies has to be taken into consideration, Such students whose parent's income is affected due to unfortunate death of one of earning parents and resultantly comes within the income ceiling prescribed under the scheme, shall become eligible for scholarship, subject to their fulfilling other conditions of eligibility , from the month in which such sad incidence takes place. Applications for scholarships from such students can be considered even after lapse of last date of receipt of applications, on compassionate grounds.

Note 2 : House Rend Allowance received by the parents of a student shall be exempted from the computation of 'income' if the same has been permitted to be exempted for purpose of Income-Tax.

Note -3: Income Certificate is required to be taken once only, i.e., at the time of admission of courses which are continuing for more than one year.

#### IV VALUE OF SCHOLARSHIP :

The value of scholarship will include maintenance allowance, reader charges for blind student, reimbursement of compulsory non refundable fees, study tour charges, thesis typing/printing charges and book allowance for students pursuing correspondence courses, for complete duration of the course. The details are given below :-

#### Note 1 COMMERCIAL PILOT LICENCE COURSE (CPL)

CPL course shall be covered under Group 'B'. The number of awards for CPL will be 20 per annum. Consequent upon receiving applications from concerned students, concerned State Governments/ UT Admns. Should scrutinize them for determining their eligibility under the Scheme and thereafter intimate the number of eligible applications for CPL training (with their names) for each financial year to Ministry of Social Justice and Empowerment (the applications themselves need not be sent to the Ministry). Upon receipt of such information, Ministry of Social Justice and Empowerment will give clearance to the concerned states/UTs on the first come first serve basis upto 20 awards for the country as a whole. The selected candidates will be provided a maintenance allowance at rates applicable to Group 'B' courses, i.e., Rs. 290 per month for hostlers and Rs. 190 per month for date scholars. In addition all compulsory fees, including flight charges are to be provided in fee.

Note 2 M. Phil and Ph.d courses are post graduation courses. Scholarship to such students may be paid at the rate of maintenance allowance for Group 'A', 'B' or 'C' depending on the course under these groups.

Note 3 : Scholars who are entitled to free board/ and or lodging will be paid maintenance charges at 1/3rd of Hostlers rate.

ii) Reader charges for blind students (Blind Scholars)

The blind scholars will be given additional amount as 'Readers Charges' as mentioned below :-

iii) Fees

Scholars will be paid enrolment/registration, tuition, games, Union, Library, Magazine, Medical Examination and such other fees compulsorily payable by the scholar to the institution or University/Board. Refundable deposit like caution money, security deposit will however, be excluded.

iv) Study Tours

Study tour charges upto a maximum of Rs. 500 per annum limited to the actual expenditure incurred by the student on transportation charges etc. will be paid to the scholars studying professional and technical courses, provided that the head of the institution certified that the study tour is essential for the scholar for completion of his/her course of study.

v) Thesis Typing/Printing charges

Thesis typing/printing charges upto a maximum of Rs. 600 will be paid to research scholars on the recommendation of the Head of the institution.

#### V) ELECTION OF CANDIDATES

All the eligible Other Backward Classes candidates will be given scholarships subject to the condition of eligibility prescribed in para III of this scheme. Candidates belonging to one State but studying in another State will be awarded scholarship by the State to which they belong and will submit their applications to the competent authorities in that

State. In the matter of exemption from fees or other concessions also they will be treated as if they were studying in their own State.

#### VI) DURATION AND RENEWAL OF AWARDS.

i) The award once made will be tenable from the stage at which it is given to the completion of course subject to good conduct and regularity in attendance. It will be renewed from year to year provided that within a course which is continuous for a number of years, the scholar secures promotion to the next higher class irrespective of the fact whether such examinations are conducted by a University or the Institution.

ii) If an OBC scholar pursuing Group A courses fails in the examination for the first time, the award may be renewed. For second and subsequent failures in any class the student shall bear his/ her own expenses until he/she secures promotion to the next higher class.

iii) If a scholar is unable to appear in the annual examination owing to illness and or on account of any other unforeseeable event, the award may be renewed for the next academic year on submission of medical certificate and or other required sufficient proof to the satisfaction of the Head of the Institution and hi/her certifying that the scholar would have passed had he appeared in the examination.

iv) If according to the Regulations of a University/Institution, a student is promoted to the next higher class even though he/she may not have actually passed in lower class and is required to take examination of the junior class again after sometime, he/she will be entitled to scholarship for the class to which he/she is promoted if the student is otherwise eligible for scholarship.

#### VII PAYMENT

i) Maintenance charges shall be payable from 1st April or from the month of admission, whichever is later, to the month in which the examinations are completed at the end of the academic year (including maintenance during holidays) provided that if the scholar secures admission after the 20th day of a month, the amount will be made from the month following the month of admission.

ii) In case of renewal of scholarships awarded in the previous years, maintenance charges will be paid from the month following the month upto which scholarship was paid in the previous year, if the course of study is continuous (e.g. from intermediate Jr. intermediate Sr. Class).

iii) All scholars are expected to purchase the necessary text books, stationery, etc. out of the maintenance allowance sanctioned. If it is reported by the Head of the concerned Institution that a scholar is without text-books stationery etc the value of the scholarship may be reduced at the discretion of the authority sanctioning the scholarship.

iv) The scholarship money will be paid to the selected students by the Government of the State/ Union Territory's Administration to which they belong in accordance with the procedure laid down by them in this regard.

v) Scholarship will not be paid for the period of internship/housemanship in the M.B.B.S. course or for a practical training in other course if the student is in receipt of some remuneration during the internship period or some allowance /stipend during the practical training in other course.

#### VIII OTHER CONDITIONS FOR THE AWARD

i) The scholarship is dependent on the satisfactory progress and conduct of the scholars. If it is reported by the Head of the Institution at any time that a scholar has by reasons of his/her own act or default failed to make satisfactory progress or has been guilty of misconduct such as resorting to or participating in strikes, irregularity in attendance without the permission of the authorities concerned etc., the authority sanctioning the scholarships may either cancel the scholarships or stop or withhold further payment for such period as it may think fit.

ii) If a student is found to have obtained a scholarship by false statement his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of the concerned State Government. The student concerned will be blacklisted and debarred for scholarship in any scheme for ever.

iii) A scholarship awarded may be cancelled if the scholar changes the subject of the course of study for which the scholarship were originally awarded or changes the

Institution of study without prior approval of the State Government. The Head of the Institution shall report such cases to them and stop payment of the scholarship money. The amount already paid may also be recovered at the discretion of the State Government.

- iv) A scholar is liable to refund the scholarship amount at the discretion of the State Government, if during the course of the year, the studies for which the scholarship has been awarded, is discontinued by him/ her.
- v) The regulations can be changed at any time at the discretion of the Government of India.

#### IX ANNOUNCEMENT OF THE SCHEME :

All the State Governments/UT Admns., will announce in May June, the details of the scheme and invite applications by issuing an advertisement in the leading newspapers of the State and through other media outfits. All requests for application forms and other particulars should be addressed to the concerned State/ UT to which students actually belong. The applicant should submit the completed application to the prescribed authority before the last date prescribed for receipt of application.

#### X PROCEDURE FOR APPLYING :

- i) An application for scholarship should comprise:
  - a) One copy of the application for scholarship in the prescribed form(Separate application forms have been prescribed for 'fresh' and renewal scholarship).
  - b) One copy of the passport size photograph with signatures of the students thereon (for fresh scholarship).
  - c) One attested copy of certificates/diploma/ degree etc. in respect of all examinations passed.
  - d) A certificate (in original of Caste duly signed by an authorized Revenue Officer now below the rank of Tehsildar.
  - e) An income declaration by the parents/guardians, stating definite income from all sources.
  - f) A receipt in acknowledgement of the scholarship in the previous year on the form attached to the application only duly countersigned by the Head of the Institution concerned, if the applicant was in receipt of a scholarship under this scheme in the preceding year.
- ii) Application complete in all respects shall be submitted to the Head of the institution being attended or last attended by the candidates and shall be addressed to an officer specified for this purpose by the Government of State/ Union Territory to which the student belong in accordance with the instructions issued by them from time to time.
- iii) In complete applications or applications received after the prescribed date will not be concerned.

#### XI) MONITORING :

The monitoring of the financial and physical performance of the scheme will be done through seeking detailed information from the Agencies implementing the Scheme . On the physical aspects the Agencies implementing the scheme will be required to furnish quarterly progress reports regarding the number of beneficiaries receiving award under the scheme , both class-wise and gender-wise. On the financial side details of actual expenditure incurred during the last financial year and expenditure proposed for the for the present financial year will be submitted by the Agencies concerned. The Agencies implanting the scheme will also be insisted upon to submit the latest audited accounts.

#### XII EVALUATION :

The Ministry of Social Justice & Empowerment may get the scheme evaluated by entrusting a research study to reputed institutions/agencies, on the performance of the

Scheme in different parts of the country, under this Ministry's centrally sponsored Scheme of Research and Training.

3. The applicant must submit this application duly completed to the authority prescribed for this purpose by the Government of the State/Union Territory to which he /she actually belongs/permanently settled, before the last date prescribed by that authority for receipt of these applications. Incomplete applications and applications received after the last date of receipt of application is over, are liable to be rejected. The application should NOT be sent to the Government of India.

**SCHOLARSHIP SCHEME FOR THE DISABLED STUDENTS**

**RULES OF SCHOLARSHIP FOR DISABLED PERSONS**

1. OBJECT : The main purpose of the scheme of scholarships for the disabled persons is to assist them to secure such education, academic, technical or professional training or even training on the shop /floor of the Industrial establishment as would enable them to earn a living and to become useful members of the society.

2.SCOPE: The scheme will be applicable to all categories of the disabled persons viz the visually Handicapped, the hearing handicapped , the orthopaedically handicapped, mentally retarded, leprosy cured and others.

**3. DEFINITION OF THE DISABLED PERSONS**

**(I) VISUALLY HANDICAPPED**

The visually handicapped are those who suffer from either of the following conditions :\_

- (a) total absence of sight.
- (b) Visual acuity not exceeding 6/60 or 20/200 (snellen) in the better eye with correcting lenses.
- (c) Limitation of the field of the vision subtending an angle of 20 degree or worse.

(ii) HEARING HANDICAPPED

The hearing handicapped are those in whom the sense of hearing is non-functional for ordinary purpose of life. They do not hear/understand sound at all even with amplified speech. The cases included in this category will be those having hearing loss more than 70 decibels in the better ear (Profound impairment) or total loss of hearing in both ears.

(iii) ORTHOPAEDICALLY HANDICAPPED

The orthopaedically handicapped are those who have a physical defect or deformity which causes interference with the normal functioning of the bones, muscles and joints.

(iv) MULTIPLE HANDICAPPED

The multiple handicapped are those who suffer from more than one disability.

(v) MENTALLY HANDICAPPED

A person shall be deemed to be mentally handicapped if his mental retardation refers to sub-average general intellectual functioning which originates during the development period and is associated with impairment in adaptive behavior.

(vi) CEREBRAL PALSY

A person with cerebral palsy is one whose motor function is impaired due to brain damage during the perinatal period or early infancy.

(vii) OTHER CATEGORIES

A person suffering from a disability not covered under definitions mentioned above, which is certified by a registered medical practitioner to have the effect of permanently reducing considerably such person's capacity for normal work or engaging in a gainful employment.

#### 4. ELIGIBILITY REQUIREMENTS :

- i. Nationality : A disabled person who is a citizen of India may apply for scholarship under this scheme.
- ii. His/her family should have resided in UT, Chandigarh continuously for three years immediately before making the application.
- iii. Scholarship will be provided to all categories of disabled persons defined earlier for pursuing general, technical and professional education from 9th class onwards.
- (iv) (a) Educational requirement:

A disabled person will be eligible for the award of scholarship for study from 9th standard onward. He/she should have secured at least 40% mark at the previous annual examination.

(b) MUSIC COURSE

A disabled person should have passed Madhyama or its equivalent examination atleast in second division from a college affiliated to a university or from institution of all India Character approved by the central Government .

(c) VOCATIONAL COURSE

A disabled person should be undertaking a vocational training course in any vocational training centre/workshop/ITI, or any other centre run by the Central/State Government/Local body or any voluntary organization or institution recognized by Central/State Government. This will also include apprenticeship or training in a recognized institution or in Industries. Lack of academic qualification need not be a bar to vocational training.

(iv) INCOME

No scholarship will be admissible if the combined monthly income of the parents/guardian of the candidate is more than Rs. 5000/-(Rupees Five thousand )

( A certificate to this effect will have to be submitted in Appendix VII).

(v) OTHER REQUIREMENTS

(a) Course : A disabled person must be studying a full time course of correspondence course in an educational institution affiliated to a board/university, music course in an institution affiliated to a university or an organization approved by the State or Central Govt. or working as trainee in a recognized institution or commercial/industrial establishment approved by the Central or State Government.

(b) A disabled student who under any scheme of the Central/State Govt. has received craft training free of cost, or undergone a course of general education free of cost will be eligible for consideration for scholarship for higher technical training or higher education. The students who want to got in for academic courses after doing craft training and vice-versa shall not however, be considered for scholarship.

Application will have to furnish an undertaking duly countersigned by his/her parent/guardian stating that he/she is not in receipt of assistance from any other source . In the event of the undertaking being found false the granting of further scholarship will be stopped and amount already paid will be recovered from the parent/guardian or from the candidate himself if he/she is an adult.

(c) Scholarship will not be awarded

i) For pursuing a parallel course of study e.g. scholarship will not be awarded to an M.A. in Economics to pursue study in M.A. Political Science.

ii) For study out of India

iii) For pursuing academic/technical course if a candidate has already completed a vocational course/training.

iv) For undertaking any training course for the second time :

Disabled person who has received any vocation training any institution including any Central or State Govt. organizations shall be considered for the award of scholarship to work as trainee in any establishment approved by the Central or State Government .

5(a) Rate of Scholarship :

The rates of scholarships for different courses of study are detailed in the Appendix –I.

6. Tenure of scholarship :

The scholarship will be tenable for a particular stage of study and is renewable from year to year within the stage of education and it will depend on promotion to the next class. However, scholarships would be limited to a period of six years after Class XII. The stage of study is as given below :-

(a) From Ninth class leading to pre-degree courses or its equivalent examination.

- (b) For courses after pre-degree or its equivalent examination upto First Degree Examination viz. BA/BSc/B.Com/Medical Engineering etc.
- (c) For post graduate course, i.e. A/MSc/M.Com/LLB/B.Ed/Chartered Accountancy /C&W, Accountancy/Company Secretaryship, etc.
- (d) For the following courses in Vocational/ Technical Professional Apprenticeship :
  - i) for the certificate course
  - ii) for the diploma course
  - iii) for the post diploma course.

(e) The period of training in commercial or any other establishment of other training shall be in each case be decided by the establishment in consultation with the Director Higher Education , UT, Chandigarh provided that the period shall not exceed one year, say with the specific approval of the Department on the basis of exceptional circumstance set down in writing .

Note : Scholarship will also be available for the course to Music.

#### 7. MODE OF APPLYING

#### 8 AWARD OF SCHOLARSHIP :

- a) All applications shall be considered by the Director Higher Education in consultation with such experts as it may consider necessary to consult. The decision of Director Higher Education in regard to the selection or rejection shall be final.
- b) Every selected candidate shall be informed of the course for which scholarship has been awarded through the head of the institution/establishment/voluntary organization.

#### 9. PAYMENT

The payment of scholarship will start from the month admission is taken and will be payable upto the month of examination/conclusion of training provided that:

- i) the period for which the scholarship is payable should not exceed the period for which the course/training is held.

ii) Scholarship is not payable for the month in which the course of study/training has not commenced before the 20th of the month or the scholar/trainee has not joined before 20th.

iii) scholarship is not payable for a month in which the course/training has terminated on or before the 8th of the month or the scholar/trainee has left the course of study/training institution/establishment before the 8th of the month.

10 . EXTENSION OF SCHOLARSHIP :

The Director Higher Education may at its discretion, extend scholarship for such period as it considers fit to cover an extension of the period of study/training of the candidate caused by failure in an examination provided that the candidate's failure is due to circumstance beyond control. Such extension shall normally be made on the advice of the head of the institution/establishment where the scholar/trainee is studying/working.

**1.BACKGROUND**

The Finance Minister in his budget speech on the union Budget 2005-06 made the following announcements :-

“ The key to empowering the Scheduled castes and scheduled tribes is to provide top class education opportunities to meritorious students. The three on going scholarship schemes for SC/ST students under the Central Plan.- Pre Matric, Post Matric and Merit based- will continue.

To provide an added incentive, I propose a new window a short list of institutes of excellence will be notified, and any SC/ST student who secures admission in one of those institutes will be awarded a larger scholarship that will meet the requirements for tuition fees, living expenses, books and a computer. “

1:2 Accordingly, the Ministry of Tribal Affairs had a re-look at the critical gaps in quality education and drafted a more liberal scholarship scheme in consonance with the budget speech, which can take care of the quality education for the ST students. It was considered apt to provide the new window to cover the funding for quality education to

ST students up to degree/post degree level without any burden on the pupils or their family.

## 2- OBJECTIVE

2.1 The scheme aims at recognizing the need to support meritorious ST students who gain admission in identified quality educational institutions, by providing full financial support to the selected meritorious students which would enable them to complete their courses of higher studies in these selected academic institutions of the country.

## 3.SALIENT FEATURES OF THE SCHEME

3.1 Coverage: The scheme will operate in all institutions notified by the Ministry of Tribal Affairs. Mota is fully authorized to finalize the list of institutes and review it periodically.

3.2 Grant of scholarships : The ST students who secure admission in these institutions will be awarded scholarships.

3.2.1 The scholarship, once awarded, will continue till the completion of the course, subject to satisfactory performance.

3.2.2 The amount of the scholarship would cover tuition fees; boarding and lodging expenses ; book grant and a one time grant for the purchase of a computer (along its accessories).

### 3.3. ELIGIBILITY

3.3.1 Those ST students who have secured admission in the notified institutions according to the norms prescribed by the respective institutions will be eligible for the scholarship under the scheme to the extent of the number of scholarships allocated to the institutes concerned. In case the number of students admitted exceeds the number of awards, then the scholarship will be restricted to the top 5 students in the inter-se merit list. The remaining students from ST category admitted in the institute in different courses shall be eligible for the Post Matric Scholarship (PMS) administered by this Ministry as a Centrally sponsored scheme, provided such students are otherwise eligible for the said scheme.

3.3.2 The total family income of the student to be eligible for this scholarship from all sources should not exceed Rs. 2.00 Lakh per annum.

3.3.3 The scholarship will be come payable immediately after a student has secured admission and has started attending the classes.

3.3.4 The scholarship will be terminated if the student fails to pass the final examination of each year or any terminal examination prescribed . He will, however, remain eligible for the Post Matric Scholarship.

## 4.PROCEDURE FOR SELECTION OF INSTITUTES

The reputed premier institutions to be covered under the scheme shall be notified by the Ministry in the first year of operation and thereafter shall be revised every year by the steering committee.

## 5. RATES AND THE NUMBER OF SCHOLARSHIPS

Under the scheme, the ST students will be awarded a scholarship to meet the requirements for

(i) full tuition fee and other non-refundable dues in respect of Govt/ Govt. Funded institutions. However, there will be a ceiling of Rs. 2.00 lakhs per annum per student for private sector institutions and Rs. 3.72lacs per student for the private sector flying clubs for commercial pilot Training .

(ii) Living expenses will be provided as per actuals subject to maximum ceiling of Rs. 2200/- per month per student (to be revised after initial period of six months from the date of launching of the scheme).

(iii) Books and stationery @ Rs.3000/- per annum per student.

(iv) Cost of a latest computer alongwith its accessories limited to Rs. 45,000/- as one time assistance during the course.

Each institute has been allocated 5 awards . The maximum limit of 5 scholarships per institute can be increased subject to an overall capping of 635 scholarship per year.

## 6.FUNDING PATTERN

6.1 The scheme will be funded by the Ministry of Tribal Affairs on 100%basis and the funds shall be released directly to the institution concerned.

6.2 The funds may be released by the Ministry of Tribal Affairs in a single installment immediately after the admission.

## 7.GENERAL PROVISIONS

7.1 The scholarship will become payable to ST students only upon securing admission in any of the institutions notified by the Ministry of Tribal Affairs.

7.2 The students, who are awarded the scholarship under the scheme, shall have to pursue the study in the respective institution on whole time basis.

7.3 The institute will select the eligible ST students on the basis of merit and shall forward the merit list of the selected students in the prescribed performa alongwith a duly verified copy of the application, proof of admission and fee chargeable etc to claim the scholarship. The institute will not charge any fee whatsoever from the students.

7.4 After disbursement, the institute will furnish a Utilization Certificate towards the amount received, which will include the signature of the scholarship holders.

7.5 The performance of the ST students covered under the scheme shall he monitored regularly by the Head of the respective institution and the same shall be reported , through a report card to the Union Ministry of Tribal Affairs at the end of each academic year.

7.6 The notified institutions shall submit progress reports of implementation of the scheme to the Union Ministry of Tribal Affairs from time to time, as required.

7.7 Any institution violating the provisions of the scheme and/ or instructions issued by the Govt. of India will be denotified.

7.8 In the event of denotification/deletion of any institution , the scholarship will continue to be available to the ST students already admitted under the scheme, if otherwise eligible tilll completion of the course, However, no fresh seats will be allotted and funds released to such denotified institutes.

7.9 The provisions of the General Financial Rules (GFR) 2005, will apply mutatis mutandis, and the institutions shall be bound by the general principles laid therein.

## **SCHEME OF 'POST-MATRIC SCHOLARSHIP' FOR STUDENTS BELONGING TO THE MINORITY COMMUNITIES**

### **1. BACKGROUND**

The Prime Minister's New 15 Point Programme for the Welfare of Minorities was announced in June, 2006. It provides that a post-matric scholarship scheme for meritorious students from minority communities would be implemented.

### **2. OBJECTIVE:**

The objective of the Scheme is to award scholarships to meritorious students belonging to economically weaker sections of minority community so as to provide them better opportunities for higher education, increase their rate of attainment in higher education and enhance their employability.

### **3. SCOPE:**

The scholarship is to be awarded for studies in India in government or private higher secondary school/college/university, including such residential institutes of the Government and eligible private institutes selected and notified in a transparent manner by the State Government/Union Territory Administration concerned. It will also cover technical and vocational courses in Industrial Training Institutes/Industrial Training Centres affiliated with the National Council for Vocational Training (NCVT) of classes XI and XII level.

### **4. ELIGIBILITY**

Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parent's/guardian's, from all sources does not exceed Rs. 2 lakh.

### **5. DISTRIBUTION**

Muslims, Sikhs, Christians, Buddhists and Zoroastrians (Parsis) have been notified as minority communities under Section 2 (c) of the National Commission for Minorities Act, 1992. The distribution of scholarship among the States/UTs will be made on the basis of population of the above notified minorities in the States/UTs of Census 2001.

### **6. EARMARKING FOR GIRL STUDENTS**

30% of scholarship will be earmarked for girl students. In case sufficient number of eligible girl students are not available, then the balance earmarked scholarships may be awarded to eligible boy students.

### **7. SELECTION PROCEDURE**

Unlike scholarship for SC and ST, there are a fixed number of scholarships for minorities is small and limited. Students from BPL families, having the lowest income shall be given preference in the ascending order. The renewal applications would be fully exhausted before the new applications are considered.

### **8. DURATION**

Scholarship will be provided for the entire course. However, maintenance allowance will be given for a period not exceeding 10 months only in an academic year.

### **9. RATE OF SCHOLARSHIP**

Actual financial assistance will be provided for course fee/tuition fee and maintenance allowance as given below subject to a maximum ceiling indicated against item concerned.

#### 10. IMPLEMENTING AGENCIES

The scheme will be implemented through the State Government/Union Territory Administration.

#### 11. CONDITIONS FOR SCHOLARSHIP

- (i) Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents from all sources does not exceed Rs. 2 lakh. Unlike scholarship for Scand ST, there are a fixed number of scholarships for minorities and hence preference for selection has been laid down. Students from BPL families, having the lowest income shall be given preference in the ascending order. The renewal application would be fully exhausted before the new applications are considered.
- (ii) The award will be discontinued if a student fails to secure 50% marks of equivalent grade in the previous final examination. Scholarship will not be awarded for more than the normal period of time taken to obtain certificate/degree/M.Phil degree/doctorate degree.
- (iii) Scholarship will not be given to more than two students in a family.
- (iv) The students should be regular in attendance for which the yardstick will be decided by the competent authority of the school/college/university.
- (v) Income certificate should be on self certification basis by way of an affidavit on non judicial stamp paper for self employed parents and from employer for employed parents.
- (vi) The school/college/university authority will certify the claim of the student of being an outstation students not residing in hostel of the institution concerned on the basis of permanent address and parent's address.
- (vii) Migration of students from one institution to another would not normally be allowed during the course of the academic year except under exceptional circumstances and in the interest of the student's academic career.
- (viii) If a student violates any other term and condition of the scholarship, the scholarship may be suspended or cancelled. The State Government/Union Territory Administration can also directly cancel the award if duly satisfied of the reasons of violation of these regulations governing the scheme.
- (ix) If a student is found to have obtained a scholarship by false statement/certificates, his/her scholarship will be cancelled forthwith and the amount of the scholarship

- paid shall be recovered, at the discretion of the concerned State Government/Union Territory Administration.
- (x) The State Government/Union Territory Administration will lay down the detailed procedure for processing and sanctioning of scholarships to eligible students.
  - (xi) Course fee/tuition fee will be credited to the school's/college's/institution's bank account. Efforts will be made for transferring it electronically through the banks.
  - (xii) Maintenance allowance will be credited to the student's bank account. Efforts will be made for transferring it electronically through the banks.
  - (xiii) The State Government/Union Territory Administration will maintain a separate account and records relating to the funds received from the Ministry and they will be subjected to inspection by the officers of the Ministry or any other agency designated by the Ministry.
  - (xiv) The student obtaining benefits under this scholarship scheme shall not be allowed to avail of benefits under any other scholarship scheme for the same purpose.
  - (xv) The State Governments/Union Territory Administration shall constitute a committee of the departments implementing such scholarship schemes to ensure that the students from the minority community, who may also belong to SC/ST.OBC category, does not avail scholarship from other sources for the same purpose and avail only from one source.
  - (xvi) The fund for distribution of scholarships in subsequent years will be released after receiving the utilization certificate for the previous year.
  - (xvii) The scheme will be evaluated at regular intervals by the Ministry or any other agency designated by the Ministry and the cost of the evaluation study will be borne by the Ministry under the provision of the scheme.
  - (xviii) The State/Union Territory shall place all relevant details of financial and physical achievements on their website.
  - (xix) The regulations can be changed at any time at the discretion of the Government of India.

## **12. ADMINISTRATIVE EXPENSES**

As the magnitude of data to be entered and processed would be enormous as the scheme gets implemented over the years, there would be a need to engage qualified skilled personnel right from the beginning to ensure that the data based computerized systems are operational. Qualified skilled personnel possessing requisite expertise to operate computer programme designed for this purpose, enter, process, analyse, monitor, retrieve and transfer data should be engaged on contract basis as per need. Data provided by the States/Union Territories will be maintained and managed by the Ministry with personnel of similar expertise to be engaged on contract basis.

A provision not exceeding 2% of the total budget will be made to meet the administrative and allied costs viz. expenditure of the States/Union Territories and the Ministry for office equipments including computers and accessories, furniture, printing of application forms, advertisements, engagement of personnel, etc. This provision will also be used for evaluation and monitoring of the scheme, through outside reputed institutions/agencies engaged by the Ministry of Minority Affairs, Government of India and the State Governments/Union Territory Administrations.

## **13. RENEWAL OF SCHOLARSHIP**

The scholarship, once awarded, may be renewed during the next academic year of the course on the production of certificate that the student has secured 50% marks in the examination.

## **14. ANNOUNCEMENT OF SCHEME**

The scheme will be announced by the concerned State Government/Union Territory Administration well in time, through advertisements in the leading language newspapers and local dailies and by using other suitable publicity media.

## **15. MODE OF APPLYING**

The concerned State Government/Union Territory Administration will supply the application forms, till such time computerized systems are made operational. The application forms should be received back along with requisite certificates/certification within the stipulated period.

**16. PATTERN OF FINANCIAL ASSISTANCE**

100% funding will be given by the Central Government to the State Government/Union Territory Administration.

**17. MONITORING & TRANSPARENCY**

The States/Union Territories implementing the scheme shall monitor the financial and physical performance of the scheme at the State/Union Territory level. For this purpose, an IT enabled monitoring mechanism shall be in place. The State/Union Territory will be required to furnish quarterly financial and physical progress reports to the receiving scholarship, indicated school/college/institute, location of school/college/institute, government or private, class, gender, new or renewal, permanent address and parents address. The States/Union Territories shall place relevant physical and financial details in their official website.

**18. EVALUATION**

The monitoring of the financial and physical performance of the scheme will be evaluated by assigning evaluation/impact studies to reputed institutions/agencies by the Ministry of Minority Affairs, Government of India.

The Director Social Welfare, Chandigarh Administration has sent a copy of Scheme of Merit-cum-Means based Scholarship to Students belonging to Minority Communities (flag ‘A’) with the request to invite applications under the scheme by giving advertisement in the newspapers and consolidated proposal in the prescribed proformas for availing funds from the Government of India may be sent the Social Welfare Department.

**OBJECT:**

The objective of the Scheme is to provide financial assistance to the poor and meritorious students belonging to the minority communities to enable them to pursue professional and technical courses.

**SCOPE:**

These scholarships are available for studies in India only and will be awarded through an Agency designated by the State Government/UT Administration for this purpose.

**NUMBER OF SCHOLARSHIP:**

Every year 20000 scholarships will be distributed among the students of minority communities throughout the country. Based on the state-wise population of these communities, the distribution of scholarship to the Union Territory of Chandigarh

is as under:-

**CONDITIONS FOR SCHOLARSHIP:**

- i) Financial assistance will be given to pursue degree and/or post graduate level technical and professional courses from a recognized institution. Maintenance allowance will be credited to the student’s account. The course fee will be paid by the State Department directly to the institute concerned.
- ii) Students who get admission to a College to pursue technical/professional courses, on the basis of a competitive examination will be eligible for the scholarship.
- iii) Student who gets admission in technical/professional courses without facing any competitive examination will also be eligible for scholarship. However, such students should have not less than 50% marks at higher secondary/graduation level. Selection of these students will be done strictly on merit basis.
- iv) Continuation of the scholarship in subsequent years will depend on successful completion of the course during the preceding year.
- v) A scholarship holder under this scheme will not avail any other scholarship/stipend for pursuing the course.
- vi) The annual income of the beneficiary/parent or guardian of beneficiary should not exceed Rs. 2.50 lakh from all sources.
- vii) The state department will advertise the scheme every year latest by 31st March and receive the application through the concerned institutions.
- viii) After scrutinizing the applications, the state department will prepare a consolidated budget for all eligible students and send an application in the prescribed pro-

forma for release of fund from the Ministry of Minority Affairs for distribution of scholarship giving the details of each students viz. name, permanent address, telephone number, annual course fee, name & address of institute, whether hosteller or day-scholar, etc.

ix) The application for release of fund from the state department must be received in the Ministry by 30th September every year.

x) The state department will maintain separate bank account and records relating to the funds received from the Ministry and they will be subjected to inspection by the officers of the Ministry or any other agency designated by the Ministry.

xi) The fund for distribution of scholarship in subsequent year will be released after receiving the utilization certificate for the previous year. Annual inspection by the officers of the Ministry or any other agencies designated by the Ministry will also be carried out.

xii) 30% scholarship will be reserved for girls of each minority community in a state which is transferable to male student of that community in case of non-availability of female candidate in that community in the concerned state.

xiii) If the target for distribution of scholarship to a particular minority community in a state/UT is not fulfilled, it will be distributed among the same minority community of other States/UTs strictly in accordance with the merit.

xiv) A student residing in a particular State/UT will be entitled for scholarship under the quota of that State/UT only irrespective of his place of study.

xv) The number of scholarship has been fixed state-wise on the basis of minority population of the states/UTs. Within the state-wise allocations, the applications from reputed institutions will be exhausted first. The list of such institutions will be made available by the Ministry of Minority Affairs.

xvi) The Scheme will be evaluated at regular intervals and the cost of the evaluation will be borne by the Ministry of Minority Affairs under the provision of the scheme. An additional provision of 3% of the total budget will be made to meet the administrative and allied costs viz. expenditure on monitoring of the scheme, impact study, evaluation study, purchase of office equipments, engaging of contract employees, if necessary and other.

xvii) expenditure to run the cell etc. This will be shared between the Ministry of Minority Affairs, Government of India and the State Governments/UT Administration.

#### Payment

i) Maintenance allowance is payable from 1st April or from the month of admission, whichever is later, to the month in which the examinations are completed, (including maintenance allowance during holidays) maximum twice a year, provided that if the scholar secures admission after the 20th day of a month, the amount will be paid from the month following the month of admission.

ii) In case of renewal of scholarships awarded in the previous years, maintenance allowance will be paid from the month following the month upto which scholarship was paid in the previous year, if the course of study is continuous.

iii) The Government of the State/Union Territory Administration, to which they belong, in accordance with the procedure laid down by them in this regard, will pay the scholarship money to the selected students.

iv) Scholarship will not be paid for the period of internship/housemanship in the M.B.B.S. course or for a practical training in other course if the student is in receipt of some remuneration during the internship period or some allowance/stipend during the practical training in other course.

#### Other Conditions for the Award

i) The scholarship is dependent on the satisfactory progress and conduct of the scholar. If it is reported by the Head of Institution at any time that a scholar has by reasons of his/her own act of default failed to make satisfactory progress or has been guilty of misconduct such as resorting to or participating in strikes, irregularity in attendance without the permission of the authorities concerned etc., the authority sanctioning the scholarship may either cancel the scholarship or stop or withhold further payment for such period as it may think fit.

ii) If a student is found to have obtained a scholarship by false statement, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of the concerned State Government. The student concerned will be blacklisted and debarred for scholarship in any scheme forever.

iii) A scholarship awarded may be cancelled if the scholar changes the subject of the course of study for which the scholarship was originally awarded or changes the Institution of study, without prior approval of the State Government. The Head of the Institution shall report such cases to them and stop payment of the scholarship money. The amount already paid may also be recovered at the discretion of the State Government.

iv) A scholar is liable to refund the scholarship amount at the discretion of the State Government, if during the course of the year, the studies for which the scholarship has been awarded, is discontinued by him/her.

v) The regulations can be changed at anytime at the discretion of the Government of India.

#### Procedure for Applying

i) An application for scholarship should comprise:

a) One copy of the application for scholarship in the prescribed form (separate application forms prescribed for 'fresh' and renewal of scholarship by the concerned State/UTs).

b) One copy of the passport size photograph with signatures of the student thereon (for fresh scholarship).

c) One attested copy of certificates, diploma, degree etc. in respect of all examination passed.

d) An income declaration by the self-employed parents/guardians, stating definite income from all sources by way of any affidavit on non-judicial stamp paper. Employed parents/guardians are required to obtain income certificate from their employer and for any additional income from other sources, they would furnish declaration by way of an affidavit on non-judicial stamp paper.

e) Proof of permanent residence.

f) A receipt in acknowledgement of the scholarship in the previous year on the form attached to the application duly counter-signed by the Head of the Institution concerned, if the application was in receipt of a scholarship under this scheme in the preceding year.

g) The State department should satisfy itself that the student belongs to a particular minority community.

iii) Application complete in all respects shall be submitted to the Head of the Institution, being attended or last attended by the candidates and shall be addressed to an officer specified for this purpose by the Government of State/Union Territory to which the student belongs, in accordance with the instructions issued by them from time to time.

#### Funding Pattern of the Scheme

The Scheme will be implemented by the State Governments and Union Territory Administrations, which receive 100% central assistance from Government of India for the total expenditure under the scheme.
