 - 4. The Tentage/furniture items should be of good quality and to the satisfaction of the undersigned.
- 5. The items of Tentage/furniture are required to be fixed well in time at the venue of the function.
- 6.The rates should include all taxes i.e. VAT, service tax freight charges etc. or imposition whatever liable in respect of the supply. The department shall not be liable to pay any tax such as VAT, service tax, freight etc.
- 7. The department has full authority to reject the supply order without assigning any reason
- 8. The rates must be quoted for F.O.R. Destination to be intimated to successful bidder by the District Education Officer, Sec-19, Chandigarh.
- 9. In case of any dispute decision of Director School Education, Chandigarh Administration will be final.
- 10. Supply order is not transferable.
- 11. The rates shall be firm and no price variation shall be allowed.
- 12. The quantity of the articles may be intimated to the successful bidder on day to day requirements. Department reserve the right to reject any or all the tender without assigning any reason.
- 13. Tender which do not comply with the above conditions are liable to be rejected.
- 14. The acceptance of the tender it will become a contract and shall be bound by the terms and conditions of the tender.

- 16. Prior to acceptance of the quotation the departmental committee may visit the place of shop/godown to check the quality of the material
- 17. The claim of damage, if any, caused to furniture during the course of function will be entertained only on the production of certificate from the committee.
