The above promotions are subject to the following conditions:-

- i) That they shall be on probation for a period of one year.
- ii) That they can be reverted back in case they are found ineligible/unsuitable in accordance with the qualifications and length of service and other eligibility conditions.
- iii) That in the event of any person possessing requisite qualification in their respective cadre is found to be senior to them but left out for promotion, despite being eligible and suitable for promotion, he/she shall have prior claim for promotion in preference to any of the officials junior to him/her.

- iv) That degrees of all the candidates are to be sent to concerned Universities /Distance Education Bureau/UGC (wherever applicable) for verification.
- v) That these promotion orders are subject to the final outcome of court cases pending relating to promotion of Lecturers before the Hon'ble Tribunal and High Court i.e. O.A No.141/CH/ 2020 titled as Mukesh Jakhar Versus Education Department, O.A No.60/827/ 2020 titled Balwinder Singh & Ors Versus Education Department, O.A No.60/1190/2020 titled Rajesh Bansal Versus Education Department, O.A.No.060/913/2020 titled Bhupinder Kaur Versus Education Department or any other case pending.
- vi) That promotion of all the teachers is subject to the vigilance clearance.
- vii) That all the teachers who are being promoted will submit an undertaking on the proforma that they fulfill all the eligibility condition as per Recruitment Rules and they have acquired qualifications from the recognized Universities/Institutions. All the norms of distance education have also been followed as notified by U.G.C. from time to time.
- viii) That their inter-se-seniority will be decided later on.


