Details of inviting tender for sale of Empty Jute Bags under Mid Day Meal Scheme

11,277 Jute bags having capacity of 50Kg Wheat in one bag are to be disposed off by sale. Interested bidders may apply alongwith Earnest Money of Rs.2000/- in the shape of bank draft drawn in favour of the District Education Officer, Chandigarh Administration and their PAN Card within a period of 10 days from the date of appearing the said public notice in the Newspaper as well as on the website. Detail of terms & conditions is given as under :-

Terms & Conditions:

- i. The rates quoted should be valid for one year from the issue of the contract letter.
- ii. The tenders must accompany earnest money of Rs. 2000/- in the shape of bank draft drawn in favor of the District Education Officer, Chandigarh Administration. The earnest money will be forfeited, if the tenderer whose rate is accepted, fails to deposit performance security within the stipulated period.
- iii. The vendor whose rates are accepted will have to lift the first lot of empty bags within 10 days from the date of issue of acceptance letter and further lots will be offered in phased manner on the approved rates and the same will be lifted by the contractor within seven days from the date of offer.
- iv. The vendor will be required to deposit cash payment on account of the cost of empty bags at the approved rates, before lifting the empty bags.
- v. The successful bidder whose rates are accepted shall be required to deposit performance security of Rs. 20,000/- in the shape of Fixed Deposit Receipt valid for fifteen months duly pledged in the name of District Education Officer, Chandigarh Administration.
- vi. If the vendor failed to lift the material as per terms and conditions, performance security shall be forfeited.
- vii. GST will be charged extra, if applicable.
- viii. Successful bidder will have to deposit TCS (Tax Collected at Source) as per provisions of Income Tax Act.
- ix. Conditional tender will be rejected straightway.
- x. The bidder shall furnish signed downloaded copy regarding acceptance all the terms & conditions of advertising tender.
- xi. The bidder should have PAN Number.
- xii. Where the conditions of contract are silent, the provisions of GFR-2017 would prevail.
