On the oral request made by the learned Solicitor General, coupled with the fact that number of respondents is high and that in that main matter service is already complete, which, could otherwise proceed for hearing in terms of the previous order, we deem it appropriate to direct the petitioners to serve the unserved respondents by dasti notice as well as additionally by paper publication within three weeks from today. Notice through paper publication can be issued in two local newspapers having wide circulation i.e. (The Tribune in English and Punjabi Tribune in Punjabi), mentioning the notified date of listing. Affidavit of service be filed within three weeks. If the concerned respondent(s) fail to appear on the date notified in the newspaper, the matter may proceed against such respondents ex-parte on the assumption that despite deemed service of notice, he/she had not chosen to appear in the proceedings. List the matters on 17th December, 2021.

Copies of 07 Notices to be published in said newspapers are also enclosed herewith. It is requested to get the same published in two local newspapers having wide circulation i.e. (The Tribune in English and Punjabi Tribune in Punjabi) by 06.12.2021 and furnish an affidavit in Supreme Court of India (through Sh. Shantanu Sagar, Govt. Counsel) well before the next date of hearing in the case in consultation with Law Officer and approval of the competent authority.

NOW, THEREFORE, TAKE NOTICE that the above petition with prayer for Interim Relief along with application for **CONDONATION OF DELAY IN FILING SLP** the will be posted for hearing before this Court on **17th December, 2021, along with the connected matters**, at 10.30 O' Clock in the forenoon or so soon thereafter as may be convenient to the Court and show cause to the court as to why condonation of delay in filing slp be not condoned and Special Leave Petition and Interim relief as prayed for be not granted and the resultant appeal be not allowed.

Take Further Notice that the prayer for interim relief after notice will also be listed before the Court on the aforesaid date.

You may file your affidavit in opposition to the petition as provided under Rule 14(1) of Order XXI, S.C.R.2013 within 3 weeks from the date of publication or not later than 2 weeks before the date appointed for hearing, whichever be earlier, but shall do so only by setting out the grounds in opposition to the questions of law or grounds set out in the SLPs and may produce such pleadings and documents filed before the Court/Tribunal against whose order the SLP is filed.

TAKE FURTHER NOTICE that if you fail to enter appearance as aforesaid, no further notice shall be given to you even after the grant of special leave for hearing of the resultant appeal and the matter above mentioned shall be disposed of in your absence.
