This is for the information of the general public that the Right of Children to Free and Compulsory Education Act 2009 provides reservation upto 25% to the students belonging to Economically Weaker Section/Disadvantaged group in the **Entry class** under section 12(1) (c). Private Unaided Recognized Schools of Chandigarh have already admitted some children for the Academic session 2021-22 under this category. After admission of these children, few seats are still vacant.

Details regarding vacant seats, eligibility age, required documents and link for Online Google Form is available in the detailed notice which is available on the website of Education Department i.e. www.chdeducation.gov.in. Details are also available on the notice board of the DEO office, sector-19 and Govt. Model Sr. Sec. School, Sector-19, Chandigarh.

Parents of the eligible students, interested for admission in any of the said schools, are advised to fill ONLINE GOOGLE FORM from **16.08.2021 to 22.08.2021**. **Forms will be accepted for nearby school only and no forms will be accepted after due date.** In case, a candidate wants to apply in more than one school, then he/ she has to fill **separate Google Form** for admission. ***Economically Weaker Section:**

Students whose parents income is upto Rs. 1,50,000/- per annum and having Income Certificate issued by Competent Authority.

***Disadvantaged group:**

Scheduled Caste, Scheduled Tribe, Children of war widows, children of disabled person with the minimum 60% disability for either of the parents as per the certificate issued by the Medical Board of General Hospital, Chandigarh or Government Medical College and Hospital Sector-32 or PGIMER Chandigarh and orphan children, residing in Union Territory of Chandigarh.

Parents of the eligible children, interested for admission of their ward in any of the above schools are advised to submit the online **Google Form** (<https://docs.google.com/forms/d/e/1FAIpQLScm8FpYQEy93xsDeES9MJq34U8QP4yBXmZnJ2pTm2nL5QSBkQ/viewform>). However, the Link is available on the website of the department i.e. www.chdeducation.gov.in 16.08.2021 to 22.08.2021. Forms will be accepted for nearby school only and no forms will be accepted after due date. In case,

a candidate wants to apply for more than one school, then he/ she has to submit Separate Google Form for admission. Advertisement Notice and Vacant seats under EWS category in the Entry class in Unaided recognized schools of UT, Chandigarh is available on notice board of DEO office, Sector-19, Chandigarh, GMSSS-19, Chandigarh and also on official website i.e. www.chdeducation.gov.in.

Dates regarding admission are as under:-

- I. Parents of the eligible children, interested for the admission of their ward will apply online through Google Form in any of schools (where the vacant seat is available) from **16.08.2021 to 22.08.2021 alongwith relevant documents** (such as DOB certificate, residence proof, Income Certificate, proof regarding disadvantaged group etc).
- II. In case of any query, the parents may contact to Dy. District Education Officer-I, O/o DEO, Sector-19, Chandigarh on any working day from **16.08.2021 to 22.08.2021 between 12.00 noon to 1.00 pm.**
- III. Registration form received upto 22.08.2021 will be sent to concerned school. Parents will contact the concerned school from **26.08.2021 to 28.08.2021 till 1.00 pm** to check the status of the admission and for further details.

Further, if any other relevant document (such as DOB certificate, residence proof) for admission under EWS category in the entry class in unaided recognized school is required by the school, the same may be submitted to the school directly.
