Your engagement shall be initially upto 31.01.2023 or till the post is filled up on regular basis either by direct recruitment, promotion or by deputation from other state as the case may be, whichever is earlier, but in no case it shall be beyond the age of 65 years on the following terms and conditions.

- (i) You will be paid remuneration as per Instructions issued by Government of India from time to time and adopted by DoP Chandigarh Administration. At present as per Govt. of India memo dated 09.12.2020 adopted by DoP vide memo dated 30.06.2022 is as under:-

6.1 A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. There will be no annual increment/percentage increase during the contract period.

6.3 No increment and Dearness allowance shall be allowed during the term of the contract.

Retired teachers will not get remuneration for summer and winter vacations/holidays.

- (ii) You are entitled for 1.5 days paid leave for each completed month of service. Accumulation of leave beyond a calendar year may not be allowed.
- (iii) You will observe school working hours as per the norms of this department. Further you will devote your whole time to your duties during the period of contract and shall not accept any other appointment/engagement, paid or otherwise and shall not engage yourself in private practice of any kind during the period of contract.
- (iv) Your engagement is purely be contractual arrangement and your will have no right against the post whatsoever and shall not be entitled to any other benefit except salary as mentioned above;
- (v) You will take classes/period as per workload/norms applicable for regular teacher.
- (vi) Teachers so engaged on contractual basis will not be part of the cadre of teachers of the School Education Department, Chandigarh.
- (vii) Your services can be discontinued by Director School Education, Chandigarh Administration at any time, for any reason without giving any notice in this regard;
- (viii) If you wish to resign, atleast one month notice must be given to the Department.
- (ix) You have to execute an agreement with the District Education Officer, UT., Chandigarh, in the form of agreement as per details which were available in DoP memo dated 09.10.2018.
- (x) The instructions issued by the GOI/Chandigarh Administration in future regarding engagement of retirees on contract basis will also be applicable to you.
- (xi) On the joining of teacher on regular basis (through direct recruitment, promotion, deputation etc.), the re-employed retired teacher in the subject/cadre who is oldest (in age) will be relieved first.
- (xii) If you remain absent or on leave for a continuous period of 30 days, his/her contract be terminated.

In case, you are willing to accept the offer on the above mentioned terms and conditions, you should submit Agreement (copy enclosed) to the District Education Officer, U.T., Chandigarh.
