**ORDER**

Under Article 235 read with Article 241-A of Punjab Education Code, the provisional recognition is granted from 01.04.2022 to 31.3.2026 to Gyandeep Model High School, Sector-20, Chandigarh upto Senior Secondary level (Class XII), subject to the following terms and conditions:-

1. Provisions of RTE Act related to admission of students under EWS category and disadvantages groups be followed in letter and spirit (wherever applicable);
2. School will follow the provision of Rules of Recognition of Punjab Education Code;
3. No particular book shop be prescribed for purchase of book/uniform etc. by the school and Instructions/guidelines issued by CBSE relating to books/uniforms are to be followed;
4. Fire Safety norms be followed meticulously and there should be no laxity in this regard on the part of school;
5. Fee should be charged from the students as per CBSE Affiliation Bye Laws & receipt be issued to the students against the money charged and provisions of The Punjab Regulation of Fee of Un-aided Educational Institutions Act, 2016 as extended to the U.T., Chandigarh & The Chandigarh, Union Territory Regulation of Fee of Un-aided Educational Institutions Rules, 2019 be followed in letter and spirit.
6. Staff engaged should be fully qualified as per NCTE notifications issued from time to time and untrained teachers should be replaced with trained ones;
7. Recognition is liable to withdrawn if the Management or the staff of the school take part in agitation directly/ indirectly against the authority of Government, or disseminate opinions tending to excite feelings of disloyalty or disaffection against Government or of enmity and hatred between different classes or if the pupils are permitted to attend political meetings or to engage in any form of political or communal agitation;
8. Government reserves the right, to grant, refuse or withdraw recognition at its entire discretion;
9. The school will not be transferred to a different Managing Body already approved by the Department;

The recognition is also subject to the following conditions:-

1. Salary be paid to the Teachers and other staff strictly as per provision of Appendix-I of CBSE Affiliation by Laws.
2. School Managing Committee must be approved by Education Department, Chandigarh Department.
3. Admission of 25% EWS students and Disadvantaged group be made upto class 8<sup>th</sup> under RTE Act, 2009 and admission of 15% EWS students from class 9<sup>th</sup> to 12<sup>th</sup> be made as per land allotment obligatory clause at Sr. No. 23 of allotment letter (provisions of Capital of Punjab (Dev. & Reg.) Act, 1952.
4. The Contract of service between management and staff be followed.
5. School busses have proper driver with valid license, fitness certificate of vehicles, fire extinguisher, speed control device, CCTV cameras and other requirements as per STA instructions.
6. Shortage of Reserve Fund should be completed within six months.
7. Fire Safety Certificate form Municipal Corporation should be obtained before the start of school i.e. July, 2023.
8. The School will not add any section/any class without the prior approval of the Department.
