Terms & Conditions for Public Auction

- 1. The mode of Auctionof unserviceable items/articles lying in the State Council of Educational Research and Training, Sector-32, UT Chandigarh will be a public auction on **As is Where is Basis.**
- 2. All the participants will have to submit the following documents on the day of auction failing which they will not be allowed to participate in the auction:
