Education Department, Chandigarh Administration had invited online applications from eligible candidates to fill up 396 posts of Junior Basic Teachers (JBT) on regular basis for which advertisement was published/uploaded on 16.01.2024. Written Test for the said posts was held on 28.04.2024. Provisional Merit list prepared on the basis of marks in the written test has also been uploaded on the website.

As per details mentioned in the advertisement, candidates 1.5 time (one and half time) the number of posts under each category were called for scrutiny of original documents under each category on 02.07.2024 & 03.07.2024. Another chance was given on dated 01.08.2024 and Final Chance was given on 11.09.2024.

After checking of original documents, it has been observed that 140 candidates are having discrepancies in the documents for the post of Junior Basic Teachers (JBT). However, before declaring these 140 candidates ineligible, they are given final opportunity to prove their eligibility on 27.11.2024 at 10:00 AM at GGMSSS, Sector-18, UT, Chandigarh before eligibility and document checking committee(s). It is clarified that no further opportunity will be given and they will be declared ineligible for the post of Junior Basic Teachers (JBT).
