**Notice Regarding Admission in Unaided Recognized Private Schools**  
**Under 25%/15% quota for the children belonging to**  
**Economically Weaker Section /Disadvantaged Group.**

This is for the information of the general public that the Right of Children to Free and Compulsory Education Act 2009 provides reservation upto 25% to the students belonging to Economically Weaker/Disadvantaged group(Scheduled Caste, Scheduled Tribe, Children of war widows, children of disabled person with the minimum 60% disability for either of the parents as per the certificate issued by the Medical Board of General Hospital, Chandigarh or Government Medical College and Hospital Sector-32 or PGIMER Chandigarh and orphan children, residing in Union Territory of Chandigarh) in the entry class under section 12(1) (c). Private Unaided Recognized Schools of Chandigarh have already admitted some children for the academic session 2019-20 under this category. However, few seats are lying vacant as detailed below:-

Parents of the eligible children, interested for admission of their ward in any of the above schools are advised to submit the Registration Form at Govt. Model Sr. Sec. School, Sector-19, Chandigarh from **8.04.2019 to 11.04.2019** between **9.00 am to 12.00 noon** on all working days. In case, a candidate wants to apply for more than one school, than he/ she has to submit **Separate Registration Form** for each school at Govt. Model Sr. Sec. School, Sector-19, Chandigarh. Format of Registration form is available on notice board of DSE Office, sector-9, DEO office, Sector-19 and GMSSS-19, Chandigarh and on website i.e. [www.chdeducation.gov.in](http://www.chdeducation.gov.in).

Registration Form is to be submitted along with the following documents:-

1. Residence proof of Chandigarh (Ration Card, Voter I-card, Electricity Bill, Water Bill, Gas Connection, valid Driving License etc. of the parents/legal guardian).
2. Attested copy of the Income Certificate issued by Tehsildar/Sub Divisional Magistrate concerned as decided by Chandigarh Administration from time to time.
3. Wherever a birth certificate under the Births, Deaths and Marriages Certificates Registration Act, 1886 (6 of 1886) is not available ,any one of the following documents shall be deemed to be proof of age of the child for the purposes of admission in schools:-
  - a. Hospital or Auxiliary Nurse and (ANM) register record;
  - b. Anganwadi record;
  - c. Declaration of the age of the child by either of the parent or guardian;
4. In case of any complaint, the parents may contact Dy. District Education Officer-I, O/o DEO, Sector-19, Chandigarh on any working day of **8.04.2019 to 11.04.2019** between 12.00 noon to 1.00 p.m.
5. Registration Form received upto 11.04.2019 will be sent to concerned schools. Parents will contact the concerned school on 16.04.2019 and 18.04.2019 at 1.00 P.M. to check the status of admission and for further details.
