2. PAY SCALE / MATRIX

The Pay scale for the post of Nursery Teachers (NTT) is Rs.9300-34800+Grade Pay Rs.4200 (Level-6) notified by Chandigarh Administration, Finance Department (Accounts Branch) vide notification no. 7000/15/8-F&P0(7)/2023/4354 dated 29.03.2023.

3. ESSENTIAL QUALIFICATIONS FOR THE POST OF NURSERY TEACHERS (NTT):-

- (i) Senior Secondary School Certificate (Class XII or its equivalent) from recognized board with at least 50% marks.

 OR
 - Senior Secondary (Class XII or its equivalent) from recognized board with atleast 45% marks in accordance with the NCTE Regulations, 2002 notified on 13th November, 2002; AND
- (ii) Diploma in Nursery Teachers Education / Pre-School Education / Early Childhood Education Programme (D.E.C.Ed.) of duration of not less than two years or B.Ed. Nursery from NCTE recognized institution."

NOTE-1: As per section 17 (4) of NCTE Act 1993,

(4) If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

As such, candidates who have passed Nursery Teachers Education / Pre-School Education /Early Childhood Education Programme (D.E.C.Ed.) of duration of not less than two years from NCTE recognized institute or B.Ed. Nursery from the institutes recognized by NCTE, shall only be eligible for appointment as Nursery Teacher.

Any candidate who has not passed Nursery Teachers Education / Pre-School Education / Early Childhood Education Programme (D.E.C.Ed.) / B.Ed. Nursery course from an institute not recognized by the NCTE shall not be eligible.

NOTE-2:-

Department of Personnel, Chandigarh Administration issued instructions vide Memo.No.28/69-IH(12)Pers.Trg. 2019/17987 dated 25.11.2019 regarding mandatory basic ICT skill. as under:-

"Certificate of ICT skill course i.e. course on computer concepts (CCC) 80 hours from a Govt. recognized institutions OR a reputed institution which is an ISO 9001 certified OR Department of Electronics Accreditation of Computer Course (DOEACC) of Govt. of India OR from NIELIT and its authorized institutions at the time of their appointment."

This condition must be satisfied before issuing of appointment letter.

MODE OF SELECTION AND SCHEME OF EXAMINATION FOR THE POST OF NTT: 4.

- Merit list for selection will be prepared on the basis of total marks obtained in i) Objective Type Test/MCQ. One objective type tests of 150 Marks will be conducted Qualifying marks for test will be 40% for all candidates. No interview will be conducted.
- Written test consisting of Multiple-choice questions will be conducted as under: ii)

Minimum qualifying marks will be 40%.

Minimum qualifying marks will be applicable and deduction of 0.25 marks will be made for each wrong Negative marking will be applicable and deduction of 0.25 marks will be made for each wrong answer.

d) The examination questions will be bilingual (English & Hindi) except for the Language papers which would be in the concerned Language only.

5. SELECTION PROCEDURE

- All the candidates who will submit ONLINE application along with requisite fees on or before the closing date will be issued admit card to appear in the written test without checking the eligibility conditions.
- ii) After the conduct of written test, answer key will be uploaded on website as per schedule for submission of objections by the candidates.
- iii) Marks obtained by the candidates in written test will be uploaded on the website.
- iv) In case two or more candidates are having same marks in written test then a candidate having higher marks in 2 years Diploma in Nursery Teachers Education / Pre-School Education /Early Childhood Education Programme or B.Ed. Nursery will rank higher in the merit. Even then if two candidates are at same rank, the candidate older in age will rank higher in merit.
- v) Merit list prepared on the basis of marks in written test will be uploaded on the website and on the basis of said merit; candidates will be called for scrutiny of original document and checking of eligibility conditions. (to be read along with point vi).
- vi) Candidates to be called for scrutiny of original documents under each category will be 1.5 times (one and half times) the number of posts under each category.
- vii) List of selected candidates will be prepared on the basis of total marks obtained in Objective Type Test. Final merit list for selection will be released after checking of eligibility conditions and ICT skill training certificates.
- viii) Merit list for selection will be released after checking of eligibility conditions and ICT skill training certificates. Provisional Appointment letters will be issued to the selected candidates after checking/verification of eligibility conditions /verification of all documents including ICT skill training certificate.

6. AGE LIMIT

- i. Candidates age should be strictly between 18 to 37 years as on 01.01.2023.
- ii. Relaxation to SC/OBC/ESM/PwBD and other category candidates will be given as per the instructions issued by Govt. of India/Chandigarh Administration. Under OBC category, candidates of those castes will be given benefits which are included in Union Territory, Chandigarh list.
- iii. Contract Teachers, Guest Teachers and Samagra Shiksha Teachers, working in Govt. Schools of Chandigarh will be given age relaxation equal to the period rounded to nearby month they worked in Govt. Schools under Chandigarh Administration. This relaxation will be applicable to the above category of teachers for direct recruitment who are working in Education Department Chandigarh/Samagra Shiksha Chandigarh on closing date for submission of application.
- iv. Age relaxation to other categories will be given as per instructions of Government of India. No candidate will be accorded age relaxation and benefit of reservation unless he/she attaches the requisite certificate issued by competent authority at the time of document verification.

7. PROCEDURE FOR SUBMISSION OF ONLINE APPLICATIONS

Application fee (non-refundable) amounting to Rs.1000/- (Rs.500/- in case of SC) will be accepted through online mode upto 08.02.2024 (upto 02.00 PM). Persons with disability are exempted for payment of fee as per instructions issued by Govt. of India. 3. Education department, Chandigarh will accept fee through ON-LINE mode only. Fee submitted by any other mode will not be accepted.

The application fee paid by the candidates whose application is incomplete or those who have not submitted their application or whose application is rejected, will not

be refunded. After submission of online application, registration form will be generated. Candidate has to take out two printouts of the registration form and the same has to be brought on the date of verification of documents (if name exists in Merit list) along

with original and photo copy of all documents. Print out of online application is NOT to be submitted either personally or through post.

Biometric verification may be carried out at the examination centre and at the time of joining of the applicant.
