- Whereas, the Education Department, U.T., Chandigarh had invited online applications from eligible candidates to fill up 303 posts of TGT (Masters/Mistress), including 26 posts of TGT (Science – Medical).
- Whereas, advertisement no. 05/2023 dated 09.02.2024 was published in leading newspapers inviting applications for 26 posts of TGT (Science – Medical) (Gen-11, SC-5, OBC-7, EWS-3) ESM-3, PwBD-2] on a regular basis. The written test was conducted by the recruitment agency from 22.06.2024 to 24.06.2024.
- 3. Whereas, the result of the written test was uploaded on the official website on 30.08.2024 and, in accordance with the terms of the advertisement, candidates up to three times the number of vacancies in each category were called for document verification.
- 4. Whereas, remarks regarding discrepancies in documents and clarifications required from candidates were uploaded on the website from time to time. Candidates were granted three opportunities to submit the required documents/clarifications.
- 5. Whereas, the candidature of the following candidates was placed before the Committee for consideration:
